Hong Kong Institute of Certified Public Accountants takes disciplinary action against a certified public accountant (practising) and a corporate practice

(HONG KONG, 12 April 2013) — A Disciplinary Committee of the Hong Kong Institute of Certified Public Accountants reprimanded Choi Kwok Man (membership number A03798) and K.M. Choi & Au Yeung Limited (corporate practice number M043) (collectively "respondents") on 12 March 2013, and ordered them to pay to the Institute a penalty of HK\$50,000 for their failure or neglect to observe, maintain or otherwise apply professional standards issued by the Institute. In addition, the respondents were ordered to pay HK\$49,640 towards the costs of the proceedings.

Choi is the managing director of the corporate practice. The Institute received information about alleged deficiencies in the work of the corporate practice regarding a compliance report of an insurance broker issued by Choi on behalf of the corporate practice. After considering the information available, the Institute lodged complaints against the respondents under section 34(1A) of the Professional Accountants Ordinance.

The Disciplinary Committee found, and by the respondents' admission, that they failed or neglected to observe, maintain or otherwise apply professional standards issued by the Institute, namely, section 100 "Introduction and Fundamental Principles" and section 130 "Professional Competence and Due Care" of the Code of Ethics for Professional Accountants.

Having taken into account the circumstances of the case, the Disciplinary Committee made the above order against the respondents under section 35(1) of the ordinance.

Under the ordinance, if the respondents are aggrieved by the order, they may give notice of an appeal to the Court of Appeal within 30 days after they are served the order.

Disciplinary proceedings of the Institute are conducted in accordance with Part V of the Professional Accountants Ordinance by a five-member Disciplinary Committee. The majority (three members) of each committee, including the chairman, are non-accountants chosen from a panel appointed by the Chief Executive of the HKSAR, and the other two members are CPAs.

Disciplinary hearings are held in public unless the Disciplinary Committee directs otherwise in the interests of justice. A hearing schedule is available at the Institute's website. A CPA who feels aggrieved by an order made by a Disciplinary Committee may appeal to the Court of Appeal, which may confirm, vary or reverse the order.

The Disciplinary Committees have the power to sanction members, member practices and registered students. Sanctions include temporary or permanent removal from membership or cancellation of a practising certificate, a reprimand, a penalty of up to \$500,000, and payment of costs and expenses of the proceedings.
