## Notice to compensation claimants

23 Sep 2015

The Securities and Futures Commission (SFC) today issues a notice to investors who were counterparties of convicted futures trader Tsoi Bun but have not come forward to receive compensation under an order made by the Court.

Tsoi was convicted of false trading and/or price rigging on the futures market. In 2014 he was ordered to pay over \$13 million into the Court to compensate each of the counterparties to his false trading and/or price rigging (Note 1).

Despite attempts by the Administrators to locate all counterparties, 207 investors have not come forward and about \$4.6 million remains unclaimed.

These counterparties are advised to follow the steps set out in the notice if they wish to receive compensation (Note 2).

## Final notice to compensation claimants

This is a notice to the people and companies listed in the Appendix, who were parties to one or more futures contracts conducted on the futures market between 2007 and 2009 in Hong Kong as set out in the Appendix.

The Court of First Instance, in a judgment dated 14 January 2014 (Note 1), held that Tsoi Bun contravened sections 295 and 296 of the *Securities and Futures Ordinance* by false trading and/or price rigging in relation to a large number of trades in the futures market between 2007 and 2009.

Under an order made by the Court in those proceedings, Tsoi paid HK\$13,688,950 into Court to compensate each counterparty to the futures contracts he bought or sold in the course of the unlawful futures trades. Tsoi's actions misled these counterparties to buy at artificially high or sell at artificially low prices.

Jackson Ip and James Wardell of Baker Tilly Hong Kong Restructuring and Recovery Limited were appointed as Administrators to pay compensation to the counterparties.

The bulk of the compensation has been paid to affected counterparties. However, despite several attempts by the Administrators to locate all counterparties, as at 23 September 2015, 207 investors have not yet been located to receive their compensation.

As at 19 March 2015, HK\$4,663,944.72 remained unclaimed. This sum has been paid into the Court.

If you were a party to any of these futures contracts, and you want to receive compensation, you should send a written request ("the Written Request") together with a copy of your Hong Kong Identity Card or passport (for individuals) / Business Registration or Certificate of Incorporation (for companies) to the Accounts Office of High Court (please refer to the contact details below). Alternatively, you can attend the Accounts Office in person with the written request and the copy of identification.

You should state the following information if you make a Written Request:

- Your full name (English and Chinese);
- Your mailing address and telephone number; and
- Quoting the case number "HCMP 1377/2009".

## 證監會向索償人發出的通知

2015年9月23日

證券及期貨事務監察委員會(證監會)今天向曾與已被定罪的期貨交易者蔡斌進行交易、但尚未前往領取根據法庭命令 作出的賠償的投資者,發出通知。

蔡被裁定在期貨市場進行虛假交易及/或操控價格的罪名成立,並於2014年被勒令向法庭繳存逾1,300萬元,以便向其進行虛假交易及/或價格操控交易所牽涉的每名交易對手作出賠償(註1)。

管理人雖已嘗試聯絡所有交易對手,但仍有207名投資者尚未前往領取賠償,而未獲認領的款額約為460萬元。

有關交易對手如有意領取賠償,請依照該通知的指示辦理有關手續(註2)。

## 致索償人的最後通知

茲向附錄所列人士及公司發出本通知。該等人士及公司為曾參與附錄所列於 2007 至 2009 年間在香港期貨市場執行的一份或以上期貨合約交易的其中一方。

原訟法庭於 2014 年 1 月 14 日頒下判決(註 1), 裁定蔡斌曾於 2007 至 2009 年間在期貨市 場進行大量虛假交易及/或價格操控交易,違反了《證券及期貨條例》第 295 及 296 條。

根據法庭在有關法律程序中作出的命令,蔡向法庭繳存了 13,688,950 港元,以便向他在該等 不法期貨交易中買入或賣出的期貨合約的每名交易對手作出賠償。蔡的作為誤導了該等交易對 手,令他們以人為設定的高價買入或以人為設定的低價賣出有關期貨合約。

天職香港重組及復資有限公司的葉昌盛及詹華達(James Wardell)獲委任為管理人,安排向 有關交易對手支付賠償。

大部分賠償均已支付予受影響的交易對手。然而,管理人雖已數度嘗試聯絡所有交易對手,惟截至 2015 年 9 月 23 日止,仍有 207 名投資者因未聯絡上而尚未領取賠償。

截至 2015 年 3 月 19 日止,仍有 4,663,944.72 港元未獲認領。此筆款項已繳存予法庭。
